In 2018, Warrior Expeditions supported 31 veterans in nine outdoor therapy programs and 14 veterans during our annual Reunion Hike. Our programs helped combat veterans transition from their wartime experiences through long-distance outdoor expeditions, including: Warrior Hike programs on the Appalachian Trail, Continental Divide Trail, Pacific Crest Trail, Arizona Trail, Ice Age Trail, Mountains-to-Sea Trail, and Buckeye Trail; Warrior Bike on the Trans-America Trail; and Warrior Paddle on the Mississippi River. Programs were full-time for 3-6 months and free of charge for participating veterans. Each veteran received all the gear, clothing, and supplies necessary to complete a long-distance expedition, as well as monthly stipends for food resupply. Veterans received general logistical support from volunteer veteran and community groups along the trails and weekly psychoeducational training from licensed clinical psychologists. The annual Reunion Hike is a multi-day hike that enabled former participants to reconnect with each other and outdoor therapy.
